VII. Reports from Borough Officials:

Mayor - Blood Drive Aug 19, 150K Grant (thanked Senetor Costa), Veterans flags (thanked Committee and #4 Firefighters), Rule signs for West Fields, Main Street brick issue, Cemetery grounds asked Solicitor Evashavik about cutting grass. Greg said only as last resort., Civil Service testing, Community Day and 8th Ave building.

Solicitor - Reviewed purchase of the 3 vehicles.

Manager – Plauque for Mr Campbell on Wm Knight Field. Recycling grant. Explained Turnkey and their role with Borough. Tax Anticipation note – Advising would like to pay now., #2 Fire hall asking to add vending machines to raise funds. West Field – Bringing concession to code, final inspection needed, handicap parking. Live Well Allegheny program, Building review by Optimus Risk Services, Catholic Union asking for donations for their booklet. Councilman Tichon advising no Borough monies should be given. Mr Varhola to collect from Council persons/Borough representatives if they wish to donate out of their pockets.

Engineer - Gave written report – In addition, discussed Act Year 41. (See added Motion #14). Council Woman – Fleming-Salopk asked how qualifications are determined for asbestos. , Year 42 – ADA door – They will provide specifications to SVCOG. Caruso paving project – Urgent project, several conversations – Drop dead deadline.

Public Works Supervisor – Gave written report. In addition, painting crosswalks for schools. Mayor Bodnar asked about new crosswalk signs and suggested we asked contact SVSD to pay for half. Councilman Votedian mentioned the yellow lines around the Carnegie Library being a safety issue. Councilman Brennan talked about handicapped signs on Main Street.
